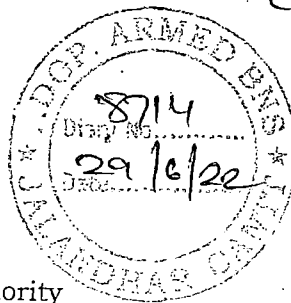
In the light of above your appeal dated 28.06.2022 under RTI Act, 2005 has been rejected being devoid of any merit.
