receipt of this letter.

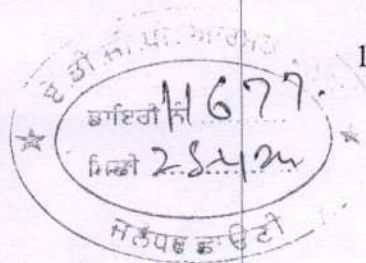
